

<b>SUMMARY OF ITEM</b>				
<p>The City Council of the City of Plano is solely responsible for naming all City-owned facilities, structures and improvements. Staff recommends adding Recreation to the title of Oak Point Center and Tom Muehlenbeck Center to be consistent with the names of the other recreation centers and to better inform the public that the facilities are a public recreation center as opposed to being a part of a college, public school or medical system. No fiscal impact. The change would start with updating written material (Leisure Brochure) and social media references. Current signage would be updated only during a facility renovation or a scheduled replacement.</p>

**WHEREAS**, the Oak Point Center and the Tom Muehlenbeck Center were built for the purpose of serving the citizens of Plano as a public recreation facility and should be identified as such; and

**WHEREAS**, the City Council of the City of Plano is solely responsible for naming all City-owned facilities, structures and improvements, whether natural or manmade, including but not limited to buildings, parks, and recreational facilities located within the City of Plano.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS, THAT:**

**Section I.** The City Council of the City of Plano hereby designates the name of the Oak Point Center as the Oak Point Recreation Center and the Tom Muehlenbeck Center as the Tom Muehlenbeck Recreation Center.

**Section II.** This Resolution shall become effective immediately upon its passage.
