





# Location Map Breckinridge Trail



**A Resolution of the City Council of the City of Plano, Texas, designating the name of the Plano-Richardson-Murphy Trail Connection as Breckinridge Trail and providing an effective date.**

**WHEREAS**, the Plano-Richardson-Murphy Trail Connection (the "Trail") was planned for the purpose of serving the citizens of Plano as an active transportation and recreational amenity providing a connection to the 417.13 acre Breckinridge Park in the City of Richardson; and

**WHEREAS**, Phase 1 of the trail is currently under construction and Phase 2 of the trail is currently under design; and

**WHEREAS**, naming the trail for the Breckinridge Park would encourage the use, accessibility, and awareness of the park; and

**WHEREAS**, the City Council of the City of Plano is authorized to name parks in the City of Plano.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS, THAT:**

**SECTION I.** The City Council of the City of Plano hereby designates the name of the trail as Breckinridge Trail.

**SECTION II.** This Resolution shall become effective upon its passage.
