SUMMARY OF ITEM				
Staff recommends the bid for the Painting of Concrete Screening Walls – Phase I to Myelyn Contractors in the amount of \$175,180 be accepted as the lowest responsible bid for the project conditioned upon timely execution of all necessary documents. This bid provides for the power washing, cleaning and painting of approximately 10,900 linear feet of concrete screening wall on Los Rios Boulevard, Park Boulevard and 15th Street. Engineer's estimate for this project is \$230,000.

All the bids were checked and three out of the four bidders had made mistakes. All bid totals were corrected and Myelyn Contractors was now the low bidder and Reconstruction Experts, Inc. had the highest bid.

The Public Works Department has checked the references and recommends award of this contract to Myelyn Contractors in the amount of \$175,188.00.




