A Resolution of the City Council of the City of Plano, Texas, canvassing the election returns of the General Election of May 9, 2015, for the election of four members of Council [Places 1, 3, 5, and 7] for a term of four years; declaring the results; and resolving other matters on the subject.

WHEREAS, for the purpose of electing four members of Council [Places 1, 3, 5 and 7] for a four (4) year term of office on the Plano City Council, the City Council called a General Election to be held on May 9, 2015, by Ordinance No. 2015-2-13, adopted on February 23, 2015; and

WHEREAS, the City Council met on May 20, 2015, and canvassed the election returns of the above-mentioned election; and

WHEREAS, it was found that the persons herein named received the stated number of votes for said term of office on the Plano City Council:

MEMBER OF COUNCIL, PLACE NO. 1

Angela Miner 5,163

MEMBER OF COUNCIL, PLACE NO. 3

Rick Grady 4,943

MEMBER OF COUNCIL, PLACE NO. 5

Mike Mansfield 2,276

Ron Kelley 4,769

MEMBER OF COUNCIL, PLACE NO. 7

Jim McGee 3,389

Tom Harrison 4,755

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS:

Section I. That in the General Election held on May 9, 2011, for Member of Council, Place No. 1, Angela Miner received a majority of all votes cast for such place; for Member of Council, Place No. 3, Rick Grady received a majority of all votes cast for such place; for Member of Council, Place No. 5, Ron Kelley received a majority of all votes cast for such place; and for Member of Council, Place No. 7, Tom Harrison received a majority of all votes cast for such place.

Section II. Angela Miner is hereby declared to be elected Council Member for Place No. 1; Rick Grady is hereby declared to be elected Council Member for Place No. 3; Ron Kelley is hereby declared to be elected Council Member for Place No. 5, and Tom Harrison is hereby declared to be elected Council Member for Place No. 7.

Section III. The City Council hereby finds and determines, as a result of this Canvass, that a total of 9,301 persons voted in the General Election held on May 9, 2015.
